

Dan's March Newsletter

Greetings Neighbor,

I want to wish you a happy March, and I hope everyone stays safe during the onand-off stormy weather. I also want to take this opportunity to talk about public safety again. As the number one issue on my mind and the minds of many residents, I want to share with you what I/we have done and what may still need to be done to adequately address the challenges of public safety in Oakland.

I'll start by reminding everyone that every police chief I've ever talked with--not only in Oakland--has said that it takes a comprehensive approach to reducing crime. That of course includes, but is not limited to, law enforcement (police).

Over the past 11 years on the Council, I have constantly advocated for increased attention to and funding for thorough criminal investigations--particularly of serious/violent crimes. This has included hiring additional police evidence techs and crime lab specialists, as well as assigning enough sworn personnel to OPD's Criminal Investigations Division. You can't hold anyone accountable if you don't solve the crime and a create a file of evidence that allows for consequences. Even if you want to require or offer the perpetrator some type of mandatory non-incarceration program option, you still have to solve the crime in order to have the leverage to get them into such a supervised program. Investigations are key--which is why I have always been a strong supporter of OPD borrowing trained FBI investigators for felony crimes involving gun violence. The City Council has issued directives during budget decision times saying that criminal investigations should not be reduced at OPD. We must continue in that vein and make sure that is followed.

I and my colleagues have always prioritized getting guns off our streets and out of the hands of people who should never have them. I authored our local law to ban ghost guns and the parts that make them. And I also wrote the local law that requires safe storage of guns in homes making it harder to steal someone's gun (that could later be used in the commission of a crime) and reduce the likelihood that young children might accidentally shoot themselves. I have worked with and will continue to work closely with Brady, Giffords and Moms Demand Action on smart gun regulation, and I have supported gun buy-back efforts in Oakland and beyond.

As you may recall, I crafted local legislation that the Council adopted a few months ago to direct the City Administrator--and OPD--to take specific actions that would make residents/visitors tangibly safer in our city. This includes creating a 911 dispatcher retention plan, seeking assistance from federal (FBI) and state (CHP) agencies, and engage in multi-jurisdictional operations to confiscate illegal guns, placing security cameras on freeway on-ramps and (through grants) along retail business corridors, expanding the number of walking beat officers, make those roles more permanent and supplementing them with neighborhood ambassadors, starting the process for a lateral police academy, and more. I'm working with the City Administrator to make sure these all get implemented.

Finally, I am a passionate supporter of our short and long-term violence intervention and prevention programs. I'm glad we were able to double the modest budget for our Dept. of Violence Prevention some two and-a-half years ago. We now must bolster our CeaseFire intervention program to help reduce gun violence in our community. This is a shared priority among councilmembers, the mayor, OPD and our City Administration--as it should be.

We continue to work on these very real challenges. Just last week, we did a merchant walk with OPD officers on Broadway in North Oakland. It is helpful for the state to offer assistance when needed. I thank the Governor for stepping up. As I've said for years, we also need to expand the state's rehabilitation programs to all state prisons and invest more seriously in local reentry programs.

There is more to do of course and we need to work together to succeed. Our residents and business owners are counting on us.

Oakland Mobile Community Assistance Responders (MACRO)

We want to remind everyone of a very crucial service to our community that I feel is underutilized to help with issues that do not escalate to the level of needing a law enforcement officer.

The Mobile Assistance Community Responders of Oakland (MACRO) Program is a community response program for non-violent, non-emergency 911 calls. The purpose of MACRO is to meet the needs of the community with a compassionate care first response model grounded in empathy, service, and community. MACRO's goal is to reduce responses by emergency services (Fire & Police), resulting in increased access to community-based services and resources for impacted individuals and families, and most especially for Black, Indigenous, and People of Color (BIPOC).

MACRO teams will respond to requests for service for homelessness, some behavioral or mental health concerns, noise complaints and people being drunk (and nonviolent) in public. \$1.1 Million in Grant Funding Available for Waste Prevention

StopWaste is offering grants with a total of \$1.1 million available in funding for projects in six categories. The focus is on innovative approaches to preventing waste in Alameda County and supporting local communities.

- 1. Food Waste Prevention & Recovery (up to \$30,000 per grant)
- 2. Surplus Food Donation Equipment (nonprofits only, up to \$10,000 per grant)
- 3. Community Food Systems (up to \$10,000 per grant)
- 4. Reusable Foodware (up to \$25,000 per grant)
- 5. Reuse & Repair (up to \$25,000 per grant)
- 6. Reusable Transport Packaging Equipment (up to \$10,000 per grant)

Ali has served with many organizations in Oakland including SPAAT, the Sparkpoint Center, Oakland Unite Street Services, and Center Point Inc. Ali Rasheed led the reentry service efforts of Center Point Inc. in Oakland and Alameda County, and has been an invaluable part of our city's fabric. Center Point Inc's rehabilitation services for those formerly incarcerated have been proved to reduce instances of substance abuse, relapse and recidivism among those who participated in the program.

Ali is currently working at Building Opportunities for Self-Sufficiency (BOSS) continuing his great engaged work for our community. We give our heartfelt thanks to Ali Rasheed for his tremendous work and commitment, and we honor his legacy of service here in Oakland.



Dan's Ballot Measure Recommendations

YES on Proposition 1 – Prop. 1 is (A) a general obligation bond for mental health and residential drug treatment facilities, supportive housing for homeless veterans, and grants for mental health and related housing infrastructure; and (B) statutory modifications to the 20-year-old Mental Health Services Act (Prop. 63 – 2004), which enacted an additional 1% tax on incomes above \$1 million and earmarked that new

revenue to counties to fund mental health programs and services. Prop. 1 would revise and re-name the law to be called the Behavioral Health Services Act (BHSA). Importantly, it would expand the act to include treatment for drug dependency disorders. It also would change how county mental health plans are required to spend this revenue as well as increase the number of members on the designated state oversight commission. On balance, this will help with funding for housing and services for homeless residents who have behavioral health difficulties and/or drug dependency challenges.

YES on **Oakland** Measure **D** – Necessary measure to meet a state constitutional requirement, which would allow the City of Oakland to spend our revenues derived from past voter-approved tax assessments for the voter-approved priorities specified for those assessments. Does not raise anybody's taxes or tax rates.

YES on **Alameda County Charter** Measure **B** – This Alameda County Charter change would repeal County-specific requirements and procedures dealing with the process to Recall a County elected official, and instead use the designated county recall process and requirements in California State law. The new language would be, "California State law applicable to the recall of county officers shall govern the recall of County of Alameda elected officials."

YES on Alameda Measure **E** – Parcel Tax for Alameda public schools to help with teacher retention, maintaining quality academic instructional programs, smaller class size, and preparing students for college.

City Boards and Commissions

There are periodic vacancies among the City's numerous boards and commissions. To fill these vacancies quickly, we need a pool of applicants that can be vetted for these seats as they become available. Most positions are filled by the Mayor, but some are filled directly by each Councilmember.
