

# **Dan's September Newsletter**

Greetings {{FirstName or 'Neighbor'}},

I hope everyone had a wonderful summer. The City Council resumed its normal formal activities on Tuesday, September 12th, with Council committee meetings. We are considering key legislation and many other items before the end of the year as we look to address the most pressing issues facing Oakland right now. At the forefront of most everyone's mind is the serious challenge of public safety. Crime in Oakland has gone up over the past year and we are working diligently to address this reality.

Yesterday, September 19th, the city council passed a Public Safety Resolution that I sponsored. This resolution will (1) improve our 911 dispatch system by working to recruit and retain dispatchers and address grand jury recommendations, (2) moves forward a lateral police academy that could hire experienced officers, (3) requests additional FBI investigators to help OPD investigate homicides and shootings, (4) authorizes high-tech cameras on freeway on-ramps and creates a grant program so retail business associations can purchase such cameras, (5) starts the process for the Chief of Police to institute a permanent neighborhood beat officer deployment plan and to look seriously at at instituting a citywide community ambassador deployment plan as well, (6) bolsters our CeaseFire violence intervention program, (7) seeks additional funds for vital reentry programs in Alameda County, (8) urges OPD to step up their operations in coordination with federal authorities to confiscate illegal guns, (9) takes action to expand Oakland's MACRO civilian response program, and more. Implementation of this Resolution will help us address the increase in crime that we have seen in our city.

Additionally, I'm working on an ordinance updating the enabling ordinance for the Police Commission, the Community Police Review Agency and the Office of the Inspector General, along with Councilmember Jenkins. My office is also working on an ordinance adding a firearm procurement policy to the Oakland Municipal Code, along with Councilmember Kaplan.

As always, we must take a comprehensive approach to public safety and crime reduction. Prevention, Intervention and Enforcement are all part of the answer. I support having sufficient police officer overtime, improving 911 dispatch hiring and retention, and walking beat officers where needed. Restoring the budget of the Department of Violence Prevention and building our CeaseFire and MACRO programs over time is also critically important.

As mentioned in my last newsletter, the Oakland Police Commission solicited community input on what the next Oakland Police Chief should have as qualifications and experience, as well as what their priorities should be. The Police Commission has taken that feedback and has a draft of the job description on their website. I'm glad the commission has taken the public's feedback and I hope they can act fast in recruiting, interviewing candidates, and selecting the finalists for the position of our permanent Chief of Police.

**Embarcadero West Project** 



The City of Oakland's Department of Transportation is seeking consultant proposals for the design of <a href="Embarcadero West Rail Safety and Access Improvements">Embarcadero West Rail Safety and Access Improvements</a>. Located on Embarcadero West from Adeline Street to Oak Street, the project will deliver complex transportation infrastructure elements to improve safety and accessibility, strengthen connectivity, and increase access between Oakland's Downtown, West Oakland, the Port of Oakland, and the historic waterfront. As a vital freight rail and regional rail corridor, this project will deliver safety and transit benefits for Oaklanders and visitors, while supporting the region's economy and goods movement.

The prime consultant responding to the request for proposals must be licensed to practice civil engineering in California. Applicants must meet Oakland's local business requirements, and firms must be certified by the

City of Oakland to qualify as Small and/or Local Business Enterprises (more info here:

https://www.oaklandca.gov/topics/certification-recertification-for-small-and-local-businesses). Applicants must submit their proposals by September 21, 2023, and are encouraged to attend a pre-proposal meeting on August 15, 2023 (more info on the request for proposals available in iSupplier: https://www.oaklandca.gov/services/register-with-isupplier).
