

### OAKLAND REDEVELOPMENT AGENCY BACKGROUND

- The Oakland Redevelopment Agency, created on October 10, 1956, over time managed numerous projects and programs within ten Redevelopment Project Areas, that covered over 14,510 acres, roughly 40% of the City of Oakland.
- Some of the former Redevelopment Agency's best known projects include the rehabilitation of the historic Fox Theater, the Tribune Tower, the Fruitvale Transit Village, the Airport Gateway, Amtrak Platform, Lion's Creek Crossing, the Marriott Hotel and the Oakland Convention Center, City Center and the Uptown Arts & Entertainment District.
- The Redevelopment Agency was also responsible for hundreds of neighborhood infrastructure, business and property improvements and helped in the development of thousands of affordable housing units.

### REDEVELOPMENT PROJECT AREAS

The Oakland Redevelopment Agency oversaw the redevelopment of ten redevelopment project areas during its tenure.


