MODIFIED NOTICE OF PUBLIC HEARING AND REQUEST FOR PUBLIC COMMENTS

The City of Oakland invites public feedback on its draft Consolidated Annual Action Plan (AAP) for Housing and Community Development activities for the period of July 1, 2018 – June 30, 2019. Please note that the **public hearing** originally scheduled for Tuesday, July 17, 2018, has been <u>rescheduled to July 24, 2018</u> at 5:30 p.m. in the City Council Chambers, located at One City Hall Plaza, Oakland, CA 94612. All other portions of this notice remain unchanged.

Background and Summary

The U.S. Department of Housing and Urban Development (HUD) requires the City as a recipient of Federal housing and community development funds to prepare and submit an AAP that describes the needs, priorities, strategies and actions to address housing and community development needs of low and moderate-income residents. The AAP also includes the City's applications for the Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), Emergency Solutions Grant (ESG) and Housing Opportunities for Persons With AIDS (HOPWA) programs funded by HUD.

This Annual Action Plan covering the period from July 1, 2018 through June 30, 2019, describes the City's plans for use of the following grant funds:

•	HOME	\$ 3,042,249
•	HOPWA	\$ 2,835,545
•	ESG	\$ 628,532
	Total	\$ 14,090,589

The draft AAP describes a variety of specific activities proposed to be carried out with federal and non-federal funds including new construction and rehabilitation of housing, first-time homebuyer assistance, rental assistance, emergency shelter, housing and supportive service for the homeless and persons with special needs, economic development, public services and infrastructure/neighborhood improvements. The AAP also describes actions to be taken including reducing barriers to affordable housing, improving the institutional delivery structure for housing, carrying out public housing improvements and increasing resident participation, addressing lead-based paint hazards, increasing coordination between housing and social service providers, and efforts to reduce the number of persons living in poverty.
