Victims of Sexual Assault

Your immediate safety is first. Try to go to a safe place and contact the local police. You shouldn't bathe, change your clothes, wash, douche, or disturb anything in the physical surrounding until the police conduct their investigation. If you remove your clothes, place all items (including undergarments) in a paper bag and give them to the police. Call someone you trust like a friend, relative, or support person.

As a sexual assault victim, you have a right to have a victim advocate and a support person of your choosing present at any initial medical or evidentiary physical examination and any interview by law enforcement authorities, district attorneys, or defense attorneys.

You may consider seeking professional counseling after the incident. A sexual assault committed by a person known to you, including a sexual assault by your spouse, is a crime.

Victims of sexual assault may be eligible to receive financial assistance and counseling services through the CalVCB. Contact the District Attorney Victim Witness Assistance to apply.

Confidentiality of Victim Identification

In accordance with Government Code Section 6254, victims of sex crimes and domestic violence may request their names not become a matter of public record. Victims requesting confidentiality prohibit disclosure of their names to any person except for law enforcement or prosecution purposes. The victim's address cannot be disclosed except to prosecutors.

OPD recognizes that each case of a missing or abducted person creates stress and trauma for the person's family and community. OPD accepts any report of a missing person, including runaways, without delay.
